19 PARTIES

20 1. Susan Saylor (Complainant) is the Registrar/Executive Officer of the Structural Pest
21 Control Board. She brought this action solely in her official capacity and is represented in this
22 matter by Kamala D. Harris, Attorney General of the State of California, by M. Travis Peery,
23 Deputy Attorney General.

24 2. David K. Kreider (Respondent) is representing himself in this proceeding and has
25 chosen not to exercise his right to be represented by counsel.

1 ORDER

2 IT IS HEREBY ORDERED that Field Representative License No. FR 40560, issued to
3 Respondent David K. Kreider, is surrendered and accepted by the Structural Pest Control Board.

4 1. The surrender of Respondent's Field Representative License and the acceptance of
5 the surrendered license by the Board shall constitute the imposition of discipline against
6 Respondent. This stipulation constitutes a record of the discipline and shall become a part of
7 Respondent's license history with the Structural Pest Control Board.

8 2. Respondent shall lose all rights and privileges as a Field Representative in California
9 as of the effective date of the Board's Decision and Order.

10 3. Respondent shall cause to be delivered to the Board his pocket license and, if one was
11 issued, his wall certificate on or before the effective date of the Decision and Order.

12 4. If he ever applies for licensure or petitions for reinstatement in the State of California,
13 the Board shall treat it as a new application for licensure. Respondent must comply with all the
14 laws, regulations and procedures for licensure in effect at the time the application or petition is
15 filed, and all of the charges and allegations contained in Accusation No. 2015-27 shall be deemed
16 to be true, correct and admitted by Respondent when the Board determines whether to grant or
17 deny the application or petition.

18 ACCEPTANCE

19 I have carefully read the Stipulated Surrender of License and Order. I understand the
20 stipulation and the effect it will have on my Field Representative License. I enter into this
21 Stipulated Surrender of License and Order voluntarily, knowingly, and intelligently, and agree to
22 be bound by the Decision and Order of the Structural Pest Control Board.


