21 **IT IS HEREBY STIPULATED AND AGREED** by and between the parties in this  
22 proceeding that the following matters are true:  
23

24 **PARTIES**

25 1. Susan Saylor (Complainant) is the Registrar/Executive Officer of the Structural Pest  
26 Control Board, Department of Consumer Affairs ("Board"). She brought this action solely in her  
27 official capacity and is represented in this matter by Kamala D. Harris, Attorney General of the  
28 State of California, by Kriththika Vasudevan, Deputy Attorney General.





1 Order may not be altered, amended, modified, supplemented, or otherwise changed except by a  
2 writing executed by an authorized representative of each of the parties.

3 14. The parties understand and agree that facsimile copies of this Stipulated Surrender  
4 and Disciplinary Order, including facsimile signatures thereto, shall have the same force and  
5 effect as the originals.

6 15. In consideration of the foregoing admissions and stipulations, the parties agree that  
7 the Board may, without further notice or formal proceeding, issue and enter the following  
8 Disciplinary Order:

9 **ORDER**

10 IT IS HEREBY ORDERED that Field Representative License No. FR. 44498, Branch 2,  
11 issued to Jorge Alberto Sandoval is surrendered and accepted by the Structural Pest Control  
12 Board.

13 1. The surrender of Respondent's Field Representative License No. FR 44498, Branch 2  
14 and the acceptance of the surrendered license by the Board shall constitute the imposition of  
15 discipline against Respondent. This stipulation constitutes a record of the discipline and shall  
16 become a part of Respondent's license history with the Structural Pest Control Board.

17 2. Respondent shall lose all rights and privileges in California as of the effective date of  
18 the Board's Decision and Order.

19 3. Respondent shall cause to be delivered to the Board his pocket licenses and, if one  
20 was issued, his wall certificate on or before the effective date of the Decision and Order.

21 4. If Respondent ever files an application for licensure or a petition for reinstatement in  
22 the State of California, the Board shall treat it as a petition for reinstatement. Respondent must  
23 comply with all the laws, regulations and procedures for reinstatement of a revoked license in  
24 effect at the time the petition is filed, and all of the charges and allegations contained in  
25 Accusation No. 2013-50 shall be deemed to be true, correct and admitted by Respondent when  
26 the Board determines whether to grant or deny the petition.

27 5. Respondent shall pay the agency its costs of investigation and enforcement in the  
28 amount of \$2,325.00 prior to issuance of a new or reinstated license.

1 6. If Respondent should ever apply or reapply for a new license or certification, or  
2 petition for reinstatement of a license, by any other agency in the State of California, all of the  
3 charges and allegations contained in Accusation No. 2013-50 shall be deemed to be true, correct,  
4 and admitted by Respondent for the purpose of any Statement of Issues or any other proceeding  
5 seeking to deny or restrict licensure.

6 **ACCEPTANCE**

7 I have carefully read the Stipulated Surrender of License and Order. I understand the  
8 stipulation and the effect it will have on my Field Representative License No. FR 44498, Branch  
9 2. I enter into this Stipulated Surrender of License and Order voluntarily, knowingly, and  
10 intelligently, and agree to be bound by the Decision and Order of the Structural Pest Control  
11 Board.


