7	the charges brought herein and will expire on June 30, 2017, unless renewed.

9	4. Business and Professions Code ("Code") section 8620 provides, in pertinent part, that		
10	the Board may suspend or revoke a license when it finds that the holder, while a licensee or		
11	applicant, has committed any acts or omissions constituting cause for disciplinary action or in lieu		
12	of a suspension may assess a civil penalty.		
13	5. Code section 8625 states:		
14	The lapsing or suspension of a license or company registration by operation of		
15 16	law or by order or decision of the board or a court of law, or the voluntary surrender of a license or company registration shall not deprive the board of jurisdiction to proceed with any investigation of or action or disciplinary proceeding against such licensee or company, or to render a decision suspending or revoking such license or

20	Conviction of a crime substantially related to the qualifications, functions, and duties of a structural pest control operator, field representative, applicator, or registered company is a ground for disciplinary action. The certified record of

Code section 8655 states: 5 A plea or verdict of guilty or a conviction following a plea of nolo contendere made to a charge substantially related to the qualifications, functions, and duties of a 6 structural pest control operator, field representative, applicator, or registered company is deemed to be a conviction within the meaning of this article or Section 8568 of this 7 chapter. The board may order the license or registration suspended or revoked, or may decline to issue a license, when the time for appeal has elapsed, or the judgment 8 of conviction has been affirmed on appeal or when an order granting probation is made suspending the imposition of sentence, irrespective of a subsequent order under 9 the provisions of Section 1203.4 of the Penal Code allowing the individual or registered company to withdraw a plea of guilty and to enter a plea of not guilty, or 10setting aside the verdict of guilty, or dismissing the accusation, information or indictment. 11 12 COST RECOVERY 9. Code section 125.3 provides, in pertinent part, that the Board may request the 13 administrative law judge to direct a licentiate found to have committed a violation or violations of 14 the licensing act to pay a sum not to exceed the reasonable costs of the investigation and 15 enforcement of the case, with failure of the licentiate to comply subjecting the license to not being 16 renewed or reinstated. If a case settles, recovery of investigation and enforcement costs may be 17 18 included in a stipulated settlement. 19 CAUSE FOR DISCIPLINE 20 (Criminal Conviction) Respondent is subject to discipline under Code section 8649, in that he committed a 21 10.crime that is substantially related to the qualifications, functions, or duties of a field 22representative and/or an applicator. Specifically, on or about September 23, 2015, in the case 23 entitled, People v. Terren Christopher Navone, Shasta County Superior Court, Case No. 24 MC RD CRF 150003987, Respondent was convicted by the court on his plea of nolo contendere 25 of violating Penal Code section 503 (embezzlement), a misdemeanor. The circumstances of the 26crime are that between in or around January 2014 and January 2015, Respondent used, and 27 allowed his wife to use, a City of Shasta Lake fuel card for their own personal use, for a total of 28 3

\$4,512.31. The card had been issued to him for use in his capacity as an employee of the City of Lake Shasta only.

OTHER MATTERS

11. Code section 8620 provides, in pertinent part, that a respondent may request that a civil penalty of not more than \$5,000 be assessed in lieu of an actual suspension of 1 to 19 days, or not more than \$10,000 for an actual suspension of 20 to 45 days. Such request must be made at the time of the hearing and must be noted in the proposed decision. The proposed decision shall not provide that a civil penalty shall be imposed in lieu of a suspension.

9 12. Pursuant to Code section 8654, if discipline is imposed on Applicator's License
Number RA 56751 and Field Representative's License Number FR 50111, issued to Terren C.
Navone, then Terren C. Navone shall be prohibited from serving as an officer, director, associate,
partner or responsible managing employee of a registered company during the time the discipline
is imposed, and any registered company which employs, elects, or associates Terren C. Navone as
an officer, director, associate, partner or responsible managing employee shall be subject to
disciplinary action.
