17 **STIPULATED SURRENDER OF**
18 **LICENSE AND ORDER**

19 Respondent.

20 In the interest of a prompt and speedy settlement of this matter, consistent with the public
21 interest and the responsibility of the Structural Pest Control Board of the Department of
22 Consumer Affairs, the parties hereby agree to the following Stipulated Surrender and Disciplinary
23 Order which will be submitted to the Board for approval and adoption as the final disposition of
24 the Accusation.

25 PARTIES

26 1. Susan Saylor ("Complainant") is the Registrar/Executive Officer of the Structural
27 Pest Control Board. She brought this action solely in her official capacity and is represented in
28 this matter by Kamala D. Harris, Attorney General of the State of California, by Emily Y. Wada,
Deputy Attorney General.

1. George Maher Mikhael ("Respondent") is representing himself in this proceeding and
has chosen not to exercise his right to be represented by counsel.

1 1. The surrender of Respondent's Operator's License and the acceptance of the
2 surrendered license by the Board shall constitute the imposition of discipline against Respondent.
3 This stipulation constitutes a record of the discipline and shall become a part of Respondent's
4 license history with the Structural Pest Control Board.

5 2. Respondent shall lose all rights and privileges as a structural pest control operator in
6 California as of the effective date of the Board's Decision and Order.

7 3. Respondent shall cause to be delivered to the Board his pocket license and, if one was
8 issued, his wall certificate on or before the effective date of the Decision and Order.

9 4. If Respondent ever files an application for licensure or a petition for reinstatement in
10 the State of California, the Board shall treat it as a petition for reinstatement. Respondent must
11 comply with all the laws, regulations, and procedures for reinstatement of a revoked license in
12 effect at the time the petition is filed, and all of the charges and allegations contained in
13 Accusation No. 2016-45 shall be deemed to be true, correct, and admitted by Respondent when
14 the Board determines whether to grant or deny the petition.

15 The earliest that Respondent may petition for reinstatement shall be one year from the
16 effective date of the Board's Decision and Order.

17 5. Respondent shall pay the agency its costs of investigation and enforcement in the
18 amount of \$2,035.00 prior to issuance of a new or reinstated license.

19 6. If Respondent should ever apply or reapply for a new license or certification, or
20 petition for reinstatement of a license, by any other licensing agency in the State of California, all
21 of the charges and allegations contained in Accusation, No. 2016-45 shall be deemed to be true,
22 correct, and admitted by Respondent for the purpose of any Statement of Issues or any other
23 proceeding seeking to deny or restrict licensure.


24 7. Respondent shall be prohibited from serving as an officer, director, associate, partner,
25 qualifying manager, or responsible managing employee of any registered company during the
26 period that discipline is imposed on Operator License Number OPR 11945, issued to George
27 Maher Mikhael.


ACCEPTANCE
