

18 **STIPULATED SURRENDER OF**
19 **LICENSE AND ORDER**

20 IT IS HEREBY STIPULATED AND AGREED by and between the parties in this
21 proceeding that the following matters are true:

22 **PARTIES**

23 1. Susan Saylor (Complainant) is the Interim Registrar/Executive Officer of the
24 Structural Pest Control Board, Department of Pesticide Regulation. She brought this action solely
25 in her official capacity and is represented in this matter by Kamala D. Harris, Attorney General of
26 the State of California, by Langston M. Edwards, Deputy Attorney General.

27 2. Kris Stanley Crudup (Respondent) is representing himself in this proceeding and has
28 chosen not to exercise his right to be represented by counsel.

1 negotiations, and commitments (written or oral). This Stipulated Surrender of License and Order
2 may not be altered, amended, modified, supplemented, or otherwise changed except by a writing
3 executed by an authorized representative of each of the parties.

4 14. In consideration of the foregoing admissions and stipulations, the parties agree that
5 the Board may, without further notice or formal proceeding, issue and enter the following Order:

7 **ORDER**

8 IT IS HEREBY ORDERED that Operator's License No. OPR 8172, issued to Respondent
9 Kris Stanley Crudup, is surrendered and accepted by the Structural Pest Control Board.

10 1. The surrender of Respondent's Operator's License and the acceptance of the
11 surrendered license by the Board shall constitute the imposition of discipline against Respondent.
12 This stipulation constitutes a record of the discipline and shall become a part of Respondent's
13 license history with the Structural Pest Control Board.

14 2. Respondent shall lose all rights and privileges as an Operator's License in California
15 as of the effective date of the Board's Decision and Order.

16 3. Respondent shall cause to be delivered to the Board his pocket license and, if one was
17 issued, his wall certificate on or before the effective date of the Decision and Order.

18 4. If Respondent ever files an application for licensure or a petition for reinstatement in
19 the State of California, the Board shall treat it as a petition for reinstatement. Respondent must
20 comply with all the laws, regulations and procedures for reinstatement of a revoked license in
21 effect at the time the petition is filed, and all of the charges and allegations contained in
22 Accusation No. 2012-43 shall be deemed to be true, correct and admitted by Respondent when
23 the Board determines whether to grant or deny the petition.

24 5. Respondent shall pay the agency its costs of investigation and enforcement in the
25 amount of \$370.93 prior to issuance of a new or reinstated license.




