FINDINGS OF FACT

1. On or about August 21, 2015, Complainant Susan Saylor, in her official capacity as the Registrar/Executive Officer of the Structural Pest Control Board (Board), Department of Consumer Affairs, filed Accusation No. 2016-12 against Anacapa Termite & Pest Control, Inc.; Alexander Jonasson (Respondent) before the Structural Pest Control Board. (Accusation attached as Exhibit A.)

2. On or about September 27, 2007, the Board issued Company Registration Certificate No. PR 5444, Branches 2 and 3 to Respondent. The Company Registration Certificate was cancelled on January 8, 2015. On or about July 7, 2009, Branch Office Registration No. BR 5192

- 1 2. The agency has jurisdiction to adjudicate this case by default.
- 2 3. The Structural Pest Control Board is authorized to revoke Respondent's Company
- 3 Registration Certificate, Operator's License, Field Representative's License and Branch Office
- 4 Registrations, based upon the following violations alleged in the Accusation, which are supported
- 5 by the evidence contained in the Default Decision Evidence Packet in this case:
 - 6 a. Business & Professions sections 8516(b)(6), (b)(7) & (b)(9), 8636, 8638 and 8622
 - 7 and California Code of Regulations, title 16, sections 1990(a)(3), (a)(4), (a)(8) & (b)(3), 1937.14,
 - 8 1991(a)(8), 1992 and 1993(d), for Failure to Comply with Code Regulations.
 - 9 b. Business & Professions sections 8516(b)(6), (b)(7) & (b)(9), 8516(b)(6), (b)(7) &
 - 10 (b)(9) and California Code of Regulations, title 16, sections 1990(b)(3), 1991(a)(8), 1992 and
 - 11 1993(d), for Failure to Report.
 - 12 c. Business & Professions section 8638, for Failure to Complete Work.
 - 13 d. Business & Professions section 8622, in conjunction with section 8641, for Failure to
 - 14 Comply with Board's Report of Findings (ROF) Notice.
 - 15 e. Business & Professions sections 8641, 8516(b)(6) & (b)(9), 8636, 8638 and 8622 and
 - 16 California Code of Regulations, title 16, sections 1990(a)(3) & (a)(4) and 1937.14, for Failure to
 - 17 Comply with Code Regulations.
 - 18 f. Business & Professions sections 8516(b)(6) & (b)(9) and California Code of
 - 19 Regulations, title 16, section 1990(a)(4), for Failure to Report.
 - 20 g. Business & Professions section 8638, for Failure to Complete Work.
 - 21 h. Business & Professions section 8622, in conjunction with section 8641, for Failure to
 - 22 Comply with Board's ROF Notice.
 - 23 i. Business & Professions sections 8622 and 8518, in conjunction with section 8641, for
 - 24 Failure to Provide Owner with a Notice of Work Completed.

ORDER

IT IS SO ORDERED that Company Registration Certificate No. PR 5444, Branches 2 and 3, and Branch Office Registration Nos. 5192 and 5287 heretofore issued to Respondent Anacapa Termite & Pest Control, Inc.; Alexander Jonasson; and Operator's License No. OPR 11722, Branches 2 and 3, and Field Representative's License No. FR 39056, Branches 2 and 3, issued to Alexander Jonasson, are revoked.

Pursuant to Government Code section 11520, subdivision (c), Respondent may serve a written motion requesting that the Decision be vacated and stating the grounds relied on within seven (7) days after service of the Decision on Respondent. The agency in its discretion may vacate the Decision and grant a hearing on a showing of good cause, as defined in the statute.

This Decision shall become effective on February 5, 2016.
