23 IT IS HEREBY STIPULATED AND AGREED by and between the parties to the above-
24 entitled proceedings that the following matters are true:

25 **PARTIES**

26 1. Susan Saylor (Complainant) is the Registrar/Executive Officer of the Structural Pest
27 Control Board. She brought this action solely in her official capacity and is represented in this
28

1 matter by Kamala D. Harris, Attorney General of the State of California, by Vinodhini R. Keller,
2 Deputy Attorney General.

3 2. Respondent Steven Mason Marley (Respondent) is representing himself in this
4 proceeding and has chosen not to exercise his right to be represented by counsel.

5 3. On or about November 3, 2008, the Structural Pest Control Board issued Operator's
6 License No. OPR 11770 to Steven Mason Marley (Respondent). The Operator's License was in
7 full force and effect at all times relevant to the charges brought in Accusation No. 2016-47, and
8 will expire on June 30, 2017, unless renewed.

9 4. On or about August 13, 2014, the Structural Pest Control Board issued Company
10 Registration Certificate No. PR 7105 in Branches 2 and 3 to Big Pine Pest Control with
11 Respondent as Owner. The Company Registration Certificate was in full force and effect at all
12 times relevant to the charges brought in Accusation No. 2016-47.

13 5. On or about September 29, 1994, the Structural Pest Control Board issued Field
14 Representative's License No. FR 23910 to Steven Mason Marley (Respondent). The Field
15 Representative's License was in full force and effect at all times relevant to the charges brought in
16 Accusation No. 2016-47, and will expire on June 30, 2018, unless renewed.

17 JURISDICTION

18 6. Accusation No. 2016-47 was filed before the Structural Pest Control Board (Board),
19 Department of Consumer Affairs, and is currently pending against Respondent. The Accusation
20 and all other statutorily required documents were properly served on Respondent on April 4,
21 2016. Respondent timely filed his Notice of Defense contesting the Accusation.

22 7. A copy of Accusation No. 2016-47 is attached as exhibit A and incorporated herein
23 by reference.

24 ADVISEMENT AND WAIVERS

25 8. Respondent has carefully read, and understands the charges and allegations in
26 Accusation No. 2016-47. Respondent has also carefully read, and understands the effects of this
27 Stipulated Settlement and Disciplinary Order.

1 14. The parties understand and agree that Portable Document Format (PDF) and facsimile
2 copies of this Stipulated Settlement and Disciplinary Order, including PDF and facsimile
3 signatures thereto, shall have the same force and effect as the originals.

4 15. This Stipulated Settlement and Disciplinary Order is intended by the parties to be an
5 integrated writing representing the complete, final, and exclusive embodiment of their agreement.
6 It supersedes any and all prior or contemporaneous agreements, understandings, discussions,
7 negotiations, and commitments (written or oral). This Stipulated Settlement and Disciplinary
8 Order may not be altered, amended, modified, supplemented, or otherwise changed except by a
9 writing executed by an authorized representative of each of the parties.

10 16. In consideration of the foregoing admissions and stipulations, the parties agree that
11 the Board may, without further notice or formal proceeding, issue and enter the following
12 Disciplinary Order:

13 **DISCIPLINARY ORDER**

14 IT IS HEREBY ORDERED that Operator's License No. OPR 11770, Company
15 Registration Certificate No. PR 7105, and Field Representative's License No. FR 23910 issued to
16 Respondent Steven Mason Marley are revoked. However, the revocation is stayed and
17 Respondent's licenses and certificate are placed on probation for three (3) years on the following
18 terms and conditions.

19 1. **Obey All Laws.** Respondent shall obey all Federal, State, and Local law as well as
20 all laws and rules relating to the practice of structural pest control.

21 2. **Quarterly Reports.** Respondent shall file quarterly reports with the Board during
22 the period of probation.

23 3. **Tolling of Probation.** Should Respondent leave California to reside outside this
24 state, Respondent must notify the Board in writing of the dates of departure and return. Periods
25 of residency or practice outside the state shall not apply to reduction of the probationary period.

26 4. **Notice to Employers.** Respondent shall notify all present and prospective employers
27 of the decision in case no. 2016-47, and the terms, conditions and restriction imposed on
28 Respondent by said decision.

1 Within 30 days of the effective date of this decision, and within 15 days of Respondent
2 undertaking new employment, Respondent shall cause his employer to report to the Board in
3 writing acknowledging the employer has read the decision in case No. 2016-47.

4 **5. Notice to Employees.** Respondent shall, upon or before the effective date of this
5 decision, post or circulate a notice to all employees involved in structural pest control operations
6 which accurately recite the terms and conditions of probation. Respondent shall be responsible
7 for said notice being immediately available to said employees. "Employees" as used in this
8 provision includes all full-time, part-time, temporary and relief employees and independent
9 contractors employed or hired at any time during probation.

10 **6. Completion of Probation.** Upon successful completion of probation, Respondent's
11 licenses and certificate will be fully restored.

12 **7. Violation of Probation.** Should Respondent violate probation in any respect, the
13 Board, after giving Respondent notice and an opportunity to be heard, may revoke probation and
14 carry out the disciplinary order which was stayed. If a petition to revoke probation is filed against
15 Respondent during probation, the Board shall have continuing jurisdiction until the matter is
16 final, and the period of probation shall be extended until the matter is final.

17 **8. Continuing Education Courses:** Continuing education courses completed through
18 Ace Professional Termite and Pest Control Training on June 15, 2015; June 16, 2015; June 24,
19 2015; and June 28, 2015, cannot be used towards renewal of Operator's License No. OPR 11770
20 in 2017.

21 **9. Cost Recovery:** Respondent shall pay to the Board costs associated with its
22 investigation and enforcement pursuant to Business and Professions Code section 125.3 in the
23 amount of \$1,510.00. Respondent shall be permitted to pay these costs in a payment plan
24 approved by the Board, with payments to be completed no later than three months prior to the end
25 of the probation term. Probation shall not be terminated until all costs are paid in full.


