3. On or about August 3, 2010, the Structural Pest Control Board issued Company
Registration Certificate No. PR 6103 to Sure Defense Pest Solutions, Inc., Ryan J. Fredrick, Pres.,
Kevin Michael Borges, VP (Respondent Sure Defense Pest Solutions). The Company
Registration Certificate was in full force and effect at all times relevant to the charges brought in
Accusation No. 2013-27 and was suspended on February 4, 2014 for no qualifying manager.

Field Representative License No. FR 36184

4. On or about July 17, 2003, the Board issued Field Representative' License No.
 FR 36184, in Branch 2, to Kevin M. Borges ("Respondent Borges"). On or about May 11, 2007,
 the license was upgraded to include Branch 3. On or about August 3, 2010, Respondent Borges
 became employed by and Vice President of Sure Defense Pest Solutions, Inc. The license will
 expire on June 30, 2015, unless renewed.

Applicator License No. RA 51186

S. On or about July 26, 2010, the Board issued Applicator License No. RA 51186, in
 Branch 2 and 3, to Ryan J. Frederick ("Respondent Frederick"). On or about August 3, 2010,
 Respondent Frederick became employed by and President of Sure Defense Pest Solutions, Inc.
 The license will expire on July 26, 2016, unless renewed.

JURISDICTION

Accusation No. 2013-27 was filed before the Structural Pest Control Board (Board),
 Department of Consumer Affairs, and is currently pending against Respondent. The Accusation
 and all other statutorily required documents were properly served on Respondents on December

20, 2012. Respondents timely filed their Notice of Defense contesting the Accusation. A copy of Accusation No. 2013-27 is attached as Exhibit A and incorporated by reference.

ADVISEMENT AND WAIVERS

7. Respondents Sure Defense, Kevin J. Borges, and Ryan Fredrick have carefully read, and understand the charges and allegations in Accusation No. 2013-27. Respondents also have carefully read, and understand the effects of this Stipulated Surrender of License and Order.

8. Respondents are fully aware of their legal rights in this matter, including the right to
a hearing on the charges and allegations in the Accusation; their right to be represented by
counsel, at their own expense; their right to confront and cross-examine the witnesses against
them; their right to present evidence and to testify on their own behalf; the right to the issuance of
subpoenas to compel the attendance of witnesses and the production of documents; the right to
reconsideration and court review of an adverse decision; and all other rights accorded by the
California Administrative Procedure Act and other applicable laws.

14 9. Respondents voluntarily, knowingly, and intelligently waive and give up each and
15 every right set forth above.

CULPABILITY

17 10. Respondent Sure Defense, Kevin J. Borges, and Ryan J. Fredrick admit the truth of
18 each and every charge and allegation in Accusation No. 2013-27, agree that cause exists for
19 discipline and hereby surrenders their Company Registration Certificate No. PR 6103, Field
20 Representative License No. FR 36184, and Registered Applicator License No. RA 51186 for the
21 Board's formal acceptance.

11. Respondents understand that by signing this stipulation they enable the Board to issue
an order accepting the surrender of their Company Registration Certificate, Field Representative
License and Registered Applicator License without further process.

CONTINGENCY

12. This stipulation shall be subject to approval by the Structural Pest Control Board.
Respondents understand and agree that counsel for Complainant and the staff of the Structural
Pest Control Board may communicate directly with the Board regarding this stipulation and

surrender, without notice to or participation by Respondents. By signing the stipulation. Respondents understand and agree that they may not withdraw their agreement or seek to rescind 2 3 the stipulation prior to the time the Board considers and acts upon it. If the Board fails to adopt this stipulation as its Decision and Order, the Stipulated Surrender and Disciplinary Order shall be 4 5 of no force or effect, except for this paragraph, it shall be inadmissible in any legal action between the parties, and the Board shall not be disgualified from further action by having 6 considered this matter. 7

The parties understand and agree that Portable Document Format (PDF) and facsimile 13. copies of this Stipulated Surrender of License and Order, including Portable Document Format (PDF) and facsimile signatures thereto, shall have the same force and effect as the originals.

14. This Stipulated Surrender of License and Order is intended by the parties to be an 11 12 integrated writing representing the complete, final, and exclusive embodiment of their agreement. It supersedes any and all prior or contemporaneous agreements, understandings, discussions, 13 negotiations, and commitments (written or oral). This Stipulated Surrender of License and Order 14 may not be altered, amended, modified, supplemented, or otherwise changed except by a writing 15 16 executed by an authorized representative of each of the parties.

In consideration of the foregoing admissions and stipulations, the parties agree that 17 15. the Board may, without further notice or formal proceeding, issue and enter the following Order: 18

ORDER

IT IS HEREBY ORDERED that Company Registration Certificate No. PR 6103, issued to 20 Respondent Sure Defense Pest Solutions, Inc., Ryan J. Fredrick, Pres., Field Representative 21 License No. FR 36184 issued to Kevin Michael Borges, and Registered Applicator License No. 22 RA 51186 issued to Ryan J. Fredrick, are surrendered and accepted by the Structural Pest Control 23 Board. 24

1. The surrender of Respondent's Company Registration Certificate, Field 25 Representative License, and Registered Applicator License and the acceptance of the surrendered 26 Certificate and licenses by the Board shall constitute the imposition of discipline against 27

Respondents. This stipulation constitutes a record of the discipline and shall become a part of Respondents license history with the Structural Pest Control Board.

Respondents shall lose all rights and privileges as a Registered Company, Field representative, and Registered Applicator in California as of the effective date of the Board's Decision and Order.

6 3. Respondents shall cause to be delivered to the Board their pocket license and, if one
7 was issued, their wall certificate on or before the effective date of the Decision and Order.

8 4. If Respondents ever file an application for licensure or a petition for reinstatement in
9 the State of California, the Board shall treat it as a petition for reinstatement. Respondents must
10 comply with all the laws, regulations and procedures for reinstatement of a revoked license in
11 effect at the time the petition is filed, and all of the charges and allegations contained in
12 Accusation No. 2013-27 shall be deemed to be true, correct and admitted by Respondents when
13 the Board determines whether to grant or deny the petition.

14 5. Respondents shall be jointly and severally liable and shall pay the agency its costs of
15 investigation and enforcement in the amount of \$2,779.10 prior to issuance of a new or reinstated
16 license.
