**STIPULATED SURRENDER OF  
LICENSE AND ORDER**

**( SURE DEFENSE PEST SOLUTIONS,  
INC., KEVIN MICHAEL BORGES,  
RYAN J. FREDRICK-ONLY)**

23 IT IS HEREBY STIPULATED AND AGREED by and between the parties to the above-  
24 entitled proceedings that the following matters are true:

25 PARTIES

26 1. Susan Saylor (Complainant) is the Registrar/Executive Officer of the Structural Pest  
27 Control Board. She brought this action solely in her official capacity and is represented in this  
28

1 matter by Kamala D. Harris, Attorney General of the State of California, by Elena L. Almanzo,  
2 Deputy Attorney General.

3 2. Sure Defense Pest Solutions, Inc., Kevin Michael Borges, Ryan J. Fredrick  
4 (Respondents) are representing themselves in this proceeding and has chosen not to exercise their  
5 right to be represented by counsel.

6 **Company Registration Certificate No. PR 6103**

7 3. On or about August 3, 2010, the Structural Pest Control Board issued Company  
8 Registration Certificate No. PR 6103 to Sure Defense Pest Solutions, Inc., Ryan J. Fredrick, Pres.,  
9 Kevin Michael Borges, VP (Respondent Sure Defense Pest Solutions). The Company  
10 Registration Certificate was in full force and effect at all times relevant to the charges brought in  
11 Accusation No. 2013-27 and was suspended on February 4, 2014 for no qualifying manager.

12 **Field Representative License No. FR 36184**

13 4. On or about July 17, 2003, the Board issued Field Representative' License No.  
14 FR 36184, in Branch 2, to Kevin M. Borges ("Respondent Borges"). On or about May 11, 2007,  
15 the license was upgraded to include Branch 3. On or about August 3, 2010, Respondent Borges  
16 became employed by and Vice President of Sure Defense Pest Solutions, Inc. The license will  
17 expire on June 30, 2015, unless renewed.

18 **Applicator License No. RA 51186**

19 5. On or about July 26, 2010, the Board issued Applicator License No. RA 51186, in  
20 Branch 2 and 3, to Ryan J. Frederick ("Respondent Frederick"). On or about August 3, 2010,  
21 Respondent Frederick became employed by and President of Sure Defense Pest Solutions, Inc.  
22 The license will expire on July 26, 2016, unless renewed.

23  
24 JURISDICTION

25 6. Accusation No. 2013-27 was filed before the Structural Pest Control Board (Board),  
26 Department of Consumer Affairs, and is currently pending against Respondent. The Accusation  
27 and all other statutorily required documents were properly served on Respondents on December  
28

1 20, 2012. Respondents timely filed their Notice of Defense contesting the Accusation. A copy of  
2 Accusation No. 2013-27 is attached as Exhibit A and incorporated by reference.

3 ADVISEMENT AND WAIVERS

4 7. Respondents Sure Defense, Kevin J. Borges, and Ryan Fredrick have carefully read,  
5 and understand the charges and allegations in Accusation No. 2013-27. Respondents also have  
6 carefully read, and understand the effects of this Stipulated Surrender of License and Order.

7 8. Respondents are fully aware of their legal rights in this matter, including the right to  
8 a hearing on the charges and allegations in the Accusation; their right to be represented by  
9 counsel, at their own expense; their right to confront and cross-examine the witnesses against  
10 them; their right to present evidence and to testify on their own behalf; the right to the issuance of  
11 subpoenas to compel the attendance of witnesses and the production of documents; the right to  
12 reconsideration and court review of an adverse decision; and all other rights accorded by the  
13 California Administrative Procedure Act and other applicable laws.

14 9. Respondents voluntarily, knowingly, and intelligently waive and give up each and  
15 every right set forth above.

16 CULPABILITY

17 10. Respondent Sure Defense, Kevin J. Borges, and Ryan J. Fredrick admit the truth of  
18 each and every charge and allegation in Accusation No. 2013-27, agree that cause exists for  
19 discipline and hereby surrenders their Company Registration Certificate No. PR 6103, Field  
20 Representative License No. FR 36184, and Registered Applicator License No. RA 51186 for the  
21 Board's formal acceptance.

22 11. Respondents understand that by signing this stipulation they enable the Board to issue  
23 an order accepting the surrender of their Company Registration Certificate, Field Representative  
24 License and Registered Applicator License without further process.

25 CONTINGENCY

26 12. This stipulation shall be subject to approval by the Structural Pest Control Board.  
27 Respondents understand and agree that counsel for Complainant and the staff of the Structural  
28 Pest Control Board may communicate directly with the Board regarding this stipulation and

1 surrender, without notice to or participation by Respondents. By signing the stipulation,  
2 Respondents understand and agree that they may not withdraw their agreement or seek to rescind  
3 the stipulation prior to the time the Board considers and acts upon it. If the Board fails to adopt  
4 this stipulation as its Decision and Order, the Stipulated Surrender and Disciplinary Order shall be  
5 of no force or effect, except for this paragraph, it shall be inadmissible in any legal action  
6 between the parties, and the Board shall not be disqualified from further action by having  
7 considered this matter.

8 13. The parties understand and agree that Portable Document Format (PDF) and facsimile  
9 copies of this Stipulated Surrender of License and Order, including Portable Document Format  
10 (PDF) and facsimile signatures thereto, shall have the same force and effect as the originals.

11 14. This Stipulated Surrender of License and Order is intended by the parties to be an  
12 integrated writing representing the complete, final, and exclusive embodiment of their agreement.  
13 It supersedes any and all prior or contemporaneous agreements, understandings, discussions,  
14 negotiations, and commitments (written or oral). This Stipulated Surrender of License and Order  
15 may not be altered, amended, modified, supplemented, or otherwise changed except by a writing  
16 executed by an authorized representative of each of the parties.

17 15. In consideration of the foregoing admissions and stipulations, the parties agree that  
18 the Board may, without further notice or formal proceeding, issue and enter the following Order:

19 **ORDER**

20 IT IS HEREBY ORDERED that Company Registration Certificate No. PR 6103, issued to  
21 Respondent Sure Defense Pest Solutions, Inc., Ryan J. Fredrick, Pres., Field Representative  
22 License No. FR 36184 issued to Kevin Michael Borges, and Registered Applicator License No.  
23 RA 51186 issued to Ryan J. Fredrick, are surrendered and accepted by the Structural Pest Control  
24 Board.

25 1. The surrender of Respondent's Company Registration Certificate, Field  
26 Representative License, and Registered Applicator License and the acceptance of the surrendered  
27 Certificate and licenses by the Board shall constitute the imposition of discipline against  
28

1 Respondents. This stipulation constitutes a record of the discipline and shall become a part of  
2 Respondents license history with the Structural Pest Control Board.

3 2. Respondents shall lose all rights and privileges as a Registered Company, Field  
4 representative, and Registered Applicator in California as of the effective date of the Board's  
5 Decision and Order.

6 3. Respondents shall cause to be delivered to the Board their pocket license and, if one  
7 was issued, their wall certificate on or before the effective date of the Decision and Order.

8 4. If Respondents ever file an application for licensure or a petition for reinstatement in  
9 the State of California, the Board shall treat it as a petition for reinstatement. Respondents must  
10 comply with all the laws, regulations and procedures for reinstatement of a revoked license in  
11 effect at the time the petition is filed, and all of the charges and allegations contained in  
12 Accusation No. 2013-27 shall be deemed to be true, correct and admitted by Respondents when  
13 the Board determines whether to grant or deny the petition.


14 5. Respondents shall be jointly and severally liable and shall pay the agency its costs of  
15 investigation and enforcement in the amount of \$2,779.10 prior to issuance of a new or reinstated  
16 license.
