17	entitled proceedings that the following matters are true:		
18	PARTIES		
19	1. Susan Saylor (Complainant) is the Registrar/Executive Officer of the Structural Pest		
20	Control Board. She brought this action solely in her official capacity and is represented in this		
21	matter by Kamala D. Harris, Attorney General of the State of California, by Thomas L. Rinaldi,		
22	Deputy Attorney General.		
23	2. Scott Michael Guinn (Respondent) is represented in this proceeding by attorney Scott		
24	Well, whose address is 2122 N Broadway, Santa Ana, CA 92706.		
25	3. On or about March 2, 2012, the Structural Pest Control Board issued Applicator		
26	License No. RA 52862 to Respondent. The Applicator License was in full force and effect at all		
27	times relevant to the charges brought in Accusation No. 2014-5 and will expire on March 2, 2015,		
28	unless renewed.

Stipulated Surrender of License (Case No. 2014-5)

### JURISDICTION

4. Accusation No. 2014-5 was filed before the Structural Pest Control Board (Board),
Department of Consumer Affairs, and is currently pending against Respondent. The Accusation and all other statutorily required documents were properly served on Respondent on July 23,
2013. Respondent timely filed his Notice of Defense contesting the Accusation. A copy of Accusation No. 2014-5 is attached as Exhibit A and incorporated by reference.

### ADVISEMENT AND WAIVERS

5. Respondent has carefully read, fully discussed with counsel, and understands the charges and allegations in Accusation No. 2014-5. Respondent also has carefully read, fully discussed with counsel, and understands the effects of this Stipulated Surrender of License and Order.

6. Respondent is fully aware of his legal rights in this matter, including the right to a
hearing on the charges and allegations in the Accusation; the right to be represented by counsel, at
his own expense; the right to confront and cross-examine the witnesses against him; the right to
present evidence and to testify on his own behalf; the right to the issuance of subpoenas to compel
the attendance of witnesses and the production of documents; the right to reconsideration and
court review of an adverse decision; and all other rights accorded by the California
Administrative Procedure Act and other applicable laws.

19 7. Respondent voluntarily, knowingly, and intelligently waives and gives up each and
20 every right set forth above.

## CULPABILITY

8. Respondent admits the truth of each and every charge and allegation in Accusation
No. 2014-5, agrees that cause exists for discipline and hereby surrenders his Applicator License
(No. RA 52862) for the Board's formal acceptance.

25 9. Respondent understands that by signing this stipulation he enables the Board to issue
26 an order accepting the surrender of his Applicator License without further process.

### CONTINGENCY

10. This stipulation shall be subject to approval by the Structural Pest Control Board. Respondent understands and agrees that counsel for Complainant and the staff of the Structural Pest Control Board may communicate directly with the Board regarding this stipulation and surrender, without notice to or participation by Respondent or his counsel. By signing the stipulation, Respondent understands and agrees that he may not withdraw his agreement or seek to rescind the stipulation prior to the time the Board considers and acts upon it. If the Board fails to adopt this stipulation as its Decision and Order, the Stipulated Surrender and Disciplinary Order shall be of no force or effect, except for this paragraph, it shall be inadmissible in any legal action between the parties, and the Board shall not be disqualified from further action by having considered this matter.

11. The parties understand and agree that Portable Document Format (PDF) and facsimile copies of this Stipulated Surrender of License and Order, including Portable Document Format (PDF) and facsimile signatures thereto, shall have the same force and effect as the originals.

This Stipulated Surrender of License and Order is intended by the parties to be an 15 12. integrated writing representing the complete, final, and exclusive embodiment of their agreement. 16 It supersedes any and all prior or contemporaneous agreements, understandings, discussions, 17 negotiations, and commitments (written or oral). This Stipulated Surrender of License and Order 18 may not be altered, amended, modified, supplemented, or otherwise changed except by a writing 19 executed by an authorized representative of each of the parties. 20

In consideration of the foregoing admissions and stipulations, the parties agree that 13. 21 the Board may, without further notice or formal proceeding, issue and enter the following Order: 22

#### **ORDER**

IT IS HEREBY ORDERED that Applicator License No. RA 52862, issued to Respondent 24 Scott Michael Guinn, is surrendered and accepted by the Structural Pest Control Board.

Respondent shall lose all rights and privileges as a licensed applicator in California as 1. 26 of the effective date of the Board's Decision and Order. 27

5	comply with all the laws, regulations and procedures for reinstatement of a revoked license in		
6	effect at the time the petition is filed, and all of the charges and allegations contained in		
7	Accusation No. 2014-5 shall be deemed to be true, correct and admitted by Respondent when the		
8	Board determines whether to grant or deny the petition.		
9	4. Respondent shall pay the agency its costs of investigation and enforcement in the		
10	amount of \$1,925 prior to issuance of a new or reinstated license.		
11	ACCEPTANCE		
12	I have carefully read the above Stipulated Surrender of License and Order and have fully		
13	discussed it with my attorney, Scott Well. I understand the stipulation and the effect it will have		
14	on my Applicator License. I enter into this Stipulated Surrender of License and Order		
15	voluntarily, knowingly, and intelligently, and agree to be bound by the Decision and Order of the		
16	Structural Pest Control Board.
