19	1. On or about March 24, 2015, Complainant Susan Saylor, in her official capacity as

24	Applicator License No. RA 52879 to Respondent. The Applicator License was in full force and	
25	effect at all times relevant to the charges brought in Petition to Revoke Probation No. 2013-25	
26	and expired on June 30, 2015, and has not been renewed. This lapse in licensure, however,	
27	pursuant to Business and Professions Code section 118(b) does not deprive the Board of its	
28	authority to institute or continue this disciplinary proceeding.

1	9.	Taking official notice of its own internal records, pursuant to Business and	
2	Professions Code section 125.3, it is hereby determined that the reasonable costs for Investigation		
3	and Enforcement is \$570.00 as of July 15, 2015.		
4		DETERMINATION OF ISSUES	
5	1.	Based on the foregoing findings of fact, Respondent Richard J. Sperry has subjected	
6	his Applicator License No. RA 52879 to discipline.		
7	2.	The agency has jurisdiction to adjudicate this case by default.	
8	3.	3. The Structural Pest Control Board is authorized to revoke Respondent's Applicator	
9	License based upon the following violations alleged in the Petition to Revoke Probation which		
10	are supported by the evidence contained in the Default Decision Evidence Packet in this case.		
11	a.	Respondent's probation is subject to revocation because he failed to comply with	
12	Probation Condition No. 4, requiring him to file quarterly reports despite being sent two letters		
13	reminding him of his responsibility to do so; and		
14	b.	Respondent's probation is subject to revocation because he failed to comply with	
15	Probation Condition No. 8, requiring him to pay the enforcement and prosecution costs as
