On or about July 22, 2013, the Board issued Applicator License Number RA 54686 to Patrick John Silva ("Respondent"). The license was in full force and effect at all times relevant to 23 24 the charges brought herein and will expire on June 30, 2017, unless renewed. 25 **JURISDICTION** 26 Business and Professions Code ("Code") section 8620 provides, in pertinent part, that 3. 27 the Board may suspend or revoke a license when it finds that the holder, while a licensee or 28

applicant, has committed any acts or omissions constituting cause for disciplinary action or in lieu of a suspension may assess a civil penalty.

#### 4. Code section 8625 states:

The lapsing or suspension of a license or company registration by operation of law or by order or decision of the board or a court of law, or the voluntary surrender of a license or company registration shall not deprive the board of jurisdiction to proceed with any investigation of or action or disciplinary proceeding against such licensee or company, or to render a decision suspending or revoking such license or registration.

## STATUTORY PROVISIONS

### 5. Code section 8649 states:

Conviction of a crime substantially related to the qualifications, functions, and duties of a structural pest control operator, field representative, applicator, or registered company is a ground for disciplinary action. The certified record of conviction shall be conclusive evidence thereof.

# **COST RECOVERY**

6. Code section 125.3 provides, in pertinent part, that the Registrar may request the administrative law judge to direct a licentiate found to have committed a violation or violations of the licensing act to pay a sum not to exceed the reasonable costs of the investigation and enforcement of the case.

### CAUSE FOR DISCIPLINE

## (Conviction of a Crime)

7. Respondent is subject to discipline under Code section 8649, in that on or about June 15, 2016, in the case of *People v. Patrick John Silva*, (Super. Ct. Fresno County, 2016, Case No. F16901495), Respondent was convicted by the Court on his plea of guilty of two counts of Penal Code section 211 (second degree robbery), felonies, with an enhancement of one count of violating Penal Code section 12022(b)(1) (used a deadly and dangerous weapon, to wit: a knife, in the commission and attempted commission of said offense). The circumstances of the crimes were that on or about January 13, 2016, and February 5, 2016, Respondent willfully, unlawfully, and by means of force and fear took personal property from the person, possession, and immediate presence of X.Z. and B.S., respectively.

#### **MATTERS IN AGGRAVATION**

8. On or about November 8, 2006, in the case of *People v. Patrick John Silva*, (Super. Ct. Fresno County, 2006, Case No. F06908238/F0698213), Respondent was convicted by the Court on his plea of nolo contendere of violating Penal Code section 211 (second degree robbery), a felony; Penal Code section 459/460 (second degree burglary), a felony; and Vehicle Code section 10851(a) (vehicle theft), a felony.

### **OTHER MATTERS**

- 9. Code section 8620 provides, in pertinent part, that a Respondent may request that a civil penalty of not more than \$5,000 be assessed in lieu of an actual suspension of 1 to 19 days, or not more than \$10,000 for an actual suspension of 20 to 45 days. Such request must be made at the time of the hearing and must be noted in the proposed decision. The proposed decision shall not provide that a civil penalty shall be imposed in lieu of a suspension.
- 10. Pursuant to Code section 8654, if discipline is imposed on Applicator License Number RA 54686, issued to Respondent, then Respondent shall be prohibited from serving as an officer, director, associate, partner or responsible managing employee of a licensee, and any licensee which employs, elects, or associates Respondent shall be subject to disciplinary action.

#### **PRAYER**

WHEREFORE, Complainant requests that a hearing be held on the matters herein alleged, and that following the hearing, the Structural Pest Control Board issue a decision:

- 1. Revoking or suspending Applicator License Number RA 54686, issued to Patrick John Silva;
  - 2. Revoking or suspending any other license issued to Patrick John Silva;
- 3. Prohibiting Patrick John Silva from serving as an officer, director, associate, partner, qualifying manager or responsible managing employee of any registered company during the period that discipline is imposed on Applicator License Number RA 54686, issued to Patrick John Silva;
