



CONTINUING EDUCATION

The pest control industry is always advancing, introducing new technologies, products, and methods. Continuing education (CE) offers licensees the chance to expand their expertise in pest management. For licensees, completing ongoing education is essential to remaining current with industry trends, meeting regulatory standards, and refining skills. The completion of CE hours not only strengthens their knowledge in the industry but is also a requirement for license renewal.

For licensees who renew on June 30, 2025, all CE hours must be completed between July 1, 2022, and June 30, 2025. Any hours completed outside of these dates cannot be used for your renewal.

ANTICIPATE A CONTINUING EDUCATION AUDIT

SPCB conducts random audits of licensees every year. To ensure you are ready for a potential audit, CE certificates must be retained by the licensee for three years after the date of your renewal.

If you are selected for a CE audit, a letter will be sent to you requesting that you provide all your CE certificates for the renewal period. If certificates are not provided or are not sufficient to meet the CE requirements for the license(s) that you hold, a fine may be assessed or disciplinary action may be taken on your license.

HOW TO COMPLETE YOUR RENEWAL SLIP

When you receive your license renewal in the mail, be sure to reference this page to ensure your renewal slip is complete for a stress-free renewal season. While it is important to complete all sections of the renewal slip, the following sections are the most important:

SECTION C

Write the number of CE hours completed between July 1, 2022 and June 30, 2025.

SECTION D

Original signature of licensee. Remember, licensees sign under penalty of perjury the number of CE hours they have completed. If audited, they will be asked to provide CE certificates.

SECTION H

Date renewal was signed.

SPCB PROCESSING TIMES

We strongly encourage you to return your completed renewal form and appropriate fee to SPCB as quickly as possible. It is not uncommon for renewals to take six to eight weeks for processing. You can check the status of your renewal on our License Look Up. If your expiration date reads June 30, 2025, your renewal has not been processed. If it reads June 30, 2028, your license renewal has been processed.



HOW TO APPLY ONLINE



Create an account with your personal email address. Your license will be connected to this account.



Submit an exam application if you have not already taken the exam.



Submit a re-exam application if you need to retake the exam.



Submit a license application and all required documents AFTER you have passed the exam.



Complete a live scan before or after you take the exam. You will not be issued a license until the live scan results have been received and reviewed.

FREQUENTLY ASKED QUESTIONS - EXAMS/LICENSES

1. When can I re-test?

- RA 16 days after a fail or no show.
- FR/OPR 31 days after a fail or no show.

2. Do I need a live scan?

- · Yes, you need to be fingerprinted if you've never had a license or if your license was canceled - even if you were fingerprinted before by an employer or someone else.
- No, if you are already licensed and applying to add a branch (upgrade) or another license type.

3. Do I have to be employed to apply for a license?

 No, but your license will be inactive if you are not working for a pest control company when it is issued. It will remain inactive until you submit a Transfer of Employment form.

4. How do I get a copy of my license history?

 To request your license history, send a letter to SPCB with your full name, license number, the email or mailing address where you would like the history to be sent, and your dated signature. Be sure to include a \$2 check or money order for each copy requested.

5. How do I get a pest control license?

- Submit an online exam application and fee.
- Complete a live scan. SPCB MUST receive your live scan results before issuing the license.
- After passing the exam, submit your online license application, license fee, completed request for live scan form, and any required training and experience documents.
- Check your online licensing system account or use DCA Search to see your license issue date.

6. Who can I call for information on pending DOJ/FBI results?

- Call the Department of Justice's 24-hour automated telephone service at (916) 227-4557.
- **Check your Applicant Background Check Status.**

7. How do I transfer to a different company?

• Submit a Transfer of Employment form.

8. How long is my license good for?

 Your license is good for up to three years. You MUST complete the required continuing education hours during the three-year renewal period to be eligible to renew your license.

WDO TASK FORCE UPDATE

The Wood Destroying Organism (WDO) Task Force has identified Branch 3 companies with missing or overdue WDO activity filings. The WDO Task Force is actively contacting noncompliant companies to help bring them into compliance with the Structural Pest Control Act's WDO reporting requirements.

WHAT TO EXPECT

If your company is not in compliance, the WDO Task Force will contact you by email and provide you with the following details:

- The date of your last filed WDO activity
- Your current WDO account balance
- A link to the **filing instructions**
- The form to add funds to your WDO account
- Contact details for your WDO Task Force representative

HOW WE CAN HELP

The WDO Task Force is available to assist with:

- Understanding your current filing status
- Uploading or entering WDO activities
- Depositing funds into your WDO account
- Clarifying filing requirements
- Correcting filing errors
- Managing your WDO account balance and notifications

IMPORTANT REMINDER

Business and Professions Code sections 8516 and 8518 require that all inspections, notices of work completed/not completed, and reports be filed within **10 business days**. This includes full or limited inspections, re-inspections, corrected reports, or completion reports.

The **Branch 3 Qualifying Manager** is responsible for ensuring all WDO activities are filed correctly and on time. Failure to comply could result in an audit, fines, or disciplinary action.

QUALIFYING MANAGERS

Roles and Responsibilities:

- Physical Presence Requirement: Managers must be physically present at their principal or branch office for at least nine (8 hour days) every three consecutive months.
- Supervision & Assistance: Managers are responsible for the oversight, direction, control, and inspection of the daily business and its employees, and need to be available to supervise, assist, and instruct employees as needed, to ensure full compliance with all laws and regulations of structural pest control.
- **Documentation:** In-office days must be recorded and provided to SPCB upon request.
- Consequence of Failing to Supervise: Violations committed by any partnership, corporation, firm, association, or registered company, likewise constitutes a cause for disciplinary action of the qualifying manager, whether or not he or she had knowledge of, or participated in, the prohibited act or omission.

Why Do These Matter?

- Ensures proper oversight of daily operations.
- Enhances employee support and training.
- Strengthens compliance with industry regulations.

Keep accurate records and plan ahead to stay compliant!

DEPARTMENT OF PESTICIDE REGULATION UPDATES RELATED TO YOUR **SPCB LICENSE**

New Law Regarding Neonicotinoid Pesticides for Non-Agricultural Outdoor Use

Effective January 1, 2025, neonicotinoid pesticide products used for non-agricultural purposes on outdoor trees, turf, or ornamental products can only be sold by licensed dealers and can only be possessed or used by California certified commercial applicators. The law defines the term "neonicotinoid pesticide" as a pesticide containing any of the following five ingredients: acetamiprid, clothianidin, dinotefuran, imidacloprid, or thiamethoxam. New Restrictions on Chlorophacinone and Warfarin Use

Effective January 1, 2025, most uses of the first-generation anticoagulant rodenticides (FGARs) chlorophacinone and warfarin will be prohibited under recently enacted legislation (AB 2552). DPR has published a detailed letter outlining the updated restrictions, allowed uses, and civil penalties associated with noncompliance. APPROVED REGULATIONS – FEE INCREASE

In 2024, the SPCB identified a budget shortfall caused by rising operational costs, including critical IT upgrades, mandated salary adjustments, and enforcement activities - most of which are beyond the Board's control. To address this, the Board began a formal fee regulation update in January 2025. After public comment and Board approval, the new fee structure is set to take effect on July 1, 2025.

WDO activities submitted on or after July 1, 2025 (regardless of activity date) will incur the \$5 filing fee.

WDO FILING FEE FAOS

- Q: I did an inspection on June 30th. The law says I have 10 business days to file it. If I file it on July 1st, will I have to pay the new fee?
 - A: Yes. The fee is based on the day you file, not the day you did the inspection. If you file on or after July 1st, the new \$5.00 fee will apply.

- Q: I'm behind on filing and working with the WDO Task Force/ Enforcement Team to catch up. If I don't finish until July 1st or later, will I have to pay the new fee for older work?
 - A: Yes. The fee is based on the day you submit the file, not the day the work was done.
- Q: If I upload activities to my pending queue before June 30th but don't have enough money to file them, will I still get the lower fee?
 - A: No. Activities are not officially filed until you submit them and get a confirmation number.
- Q: I need to add money to my account to file before June 30th. Can I pay online?
 - A: No. You can only add money to your WDO account by:
 - Mailing a check, cashier's check, or money order to our office.
 - Bringing payment (cash, check, cashier's check, or money order) to our office, Monday-Friday, 8:00 A.M. to 5:00 P.M.
- Q: If I mail a check and SPCB doesn't get it by June 30th, can I still pay the lower fee?
 - A: No. The new fee starts on July 1st with no exceptions. We will have extra staff on hand to process payments quickly in late June.



Review your records and file all outstanding WDO activities before June 30th to avoid paying the extra \$1 per activity.

STRUCTURAL PEST CONTROL BOARD REGULATIONS UPDATES

FUMIGATION AND PESTICIDE STANDARDS AND RECORD REQUIREMENTS

California Code of Regulations, title 16, section 1970 was updated on October 1, 2024.

Key Updates:

- 1. There is a new Standard Structural Fumigation Log (Form 43M-47, Rev. 6/2023), which can be found on our website: https://www.pestboard.ca.gov/forms/43m-47.pdf.
- 2. The requirements of the report for each structural pest control application, other than fumigation, now include:
 - A required time of application.
 - Clearer tracking of pesticide use, including product name and registration number.
 - The identity and license number of the certified commercial applicator who applied or supervised the application of restricted materials by the non-certified commercial applicator, and, if applicable, the identity and license number of the non-certified commercial applicator who applied the pesticides.

PESTICIDE APPLICATION NOTICE REQUIREMENTS

California Code of Regulations, title 16, sections 1970.4, 1970.41, 1970.42, and 1970.43 were updated on January 1, 2025.

Key Updates:

- 1. Reorganization of Pre- and Post-Pesticide Application Notices: Requirements for pre- and post-pesticide application notices (previously included in CCR § 1970.4) have now been divided into separate sections for each pest control branch: Branch 1 (Fumigation), Branch 2 (General Household Pests), and Branch 3 (Wood Destroying Pests and Organisms).
- 2. Electronic Post-Pesticide Application Notice: Post-pesticide application notices can now be provided via email, when authorized by occupant, owner, or owner's agent, for applications or use around or to the exterior of any structure, or to the interior of a commercial, industrial, or single-unit residential structure. When application or use is to the interior of a unit within a multi-unit residential structure, the post-application notice must be provided in writing and left on the door of the unit, or within the unit in an area next to the door of the unit.
- 3. Revised Occupant Fumigation Notice and Pesticide Disclosure Form (OFN):

The revised OFN (Form 43M-48 Rev. 10/2022) standardizes information provided to occupants regarding fumigation procedures, enhancing transparency and safety for consumers.

4. Protocols for Serious Injury or Fatality: Protocols for addressing serious injuries or fatalities related to pesticide applications have been reorganized into a stand-alone section to emphasize critical safety and reporting requirements.

Interim Suspension Order	An Order issued upon petition suspending a licensee or company registration from all or part of their practice of the provisions of the Structural Pest Control Act.
Petition to Revoke Probation	Charges filed against a probationer seeking revocation of their structural pest control license or company registration based upon violation(s) of probation.
Probationary License	When good cause exists to deny a license or company registration, SPCB has the option to issue a conditional license or company registration subject to probationary terms and conditions.
Statement of Issues Filed	Statement filed to deny an applicant for the commission of acts which, if committed by a licensee, would be cause for license discipline.
Surrender of License	The surrender of a license or company registration to SPCB, subject to acceptance of the surrendered license or company registration. The licensee is prohibited from engaging in the practice of structural pest control.
Stipulated Decision	Negotiated settlements waiving an administrative hearing.
